Dear Friends:

Here at MPM, we educate, explore, discover and preserve the world and its people. We both cultivate curiosity and provide authentic experiences.

The 2010 / 2011 fiscal year was a strong one for MPM, and a year of many changes. We continued our focus on building a sustainable business model. To this end, we restructured our bank debt, reducing it from \$16.3 to under \$5 million. We improved our net asset position by \$10.9 million, and grew our endowment to \$7.4 million.

This past year, we also refocused our philosophy on academics. A key part of our upcoming capital campaign will be to endow academic positions. We want MPM to be a world class museum recognized for its research and curatorial staff. We also unveiled a wonderful new MPM brand that successfully captures the essence of the Museum – that we continually inspire visitors to explore the marvels of their world.

Credit for much of this success can be given to our great board of directors, headed by Rich Meeusen, an active and engaged chairman. Together we've strengthened our board with new members, and look forward to their future achievements. We must also give thanks to the support of our donors, who continue to give generously even in uncertain financial times, as well as the staff of MPM for their ongoing dedication to making this one of the top cultural institutions in the state of Wisconsin.

Of course, despite our achievements, MPM will require careful stewardship as we face the years ahead. We would be remiss to ignore our challenges, and that we need continued support from our donor community. Our future is fragile and must be handled accordingly. However, we believe whole-heartedly in our mission, and while we acknowledge threats to our sustainability, we will never let them deter us – we will only use them to grow stronger as a business and academic institution.


